

Membership edit: After having attended and observed two meetings, Pam LaRiviere is joining the council as a member. Ken Seim opened the meeting at 6:04pm.

- 1.) Jim M led the group in discussion regarding pages 13-31 of The Sending Church.
- 2.) Partner Updates & Prayer requests:
 - CityGate is in need of two more volunteers to help with meal prep.
 - David & Susan Weinman are gearing up for the busy camp season. There is a need both for more camp staff (specifically summer staff) and a pastor for their local parish (David has been providing pulpit supply).
 - YoungLife Lee County is still searching for an Area Director and are in need of 5-6 club leaders for next school year due to attrition. Dwain's health is up and down and he would like good health for camps. More scholarship money needed for camps.
