Motions: (Note: since the following motions were submitted by a committee only a 2nd was needed.)

- 1) MSC (Jerry E/U) Approved: Session wave the standing 30-day rule for voting on a recommendation and accept Senior Pastor Search Committee unanimous recommendation to award a contract for New Hope Presbyterian Church senior pastor search process to NL Moore & Associates. Details to be negotiated, contingent on Session approval of funding in separate motion.
- 2) MSC (Jim L/U) Approved: Since time is of the essence regarding filling the position of senior pastor, Session approves a non-budgeted expense in order to enable negotiation and execution of a contract to the senior pastor search firm recommended by the Senior Pastor Search Committee and accepted by Session at the current, January 17, 2023 Session meeting. Funding in the amount of \$46,000 for services and reimbursable expenses is available in the General Reserves account.
- 3) MSC (Candy E/U) Approved: A travel expense reimbursement budget be set aside for finalist candidate (and spouse) travel and related expenses to Fort Myers and selected Senior Pastor Search Committee member(s) to travel to final candidate(s) home church(es), if determined necessary to confirm recommendation of top-ranked candidate. Funding in the amount of \$5,000 is available from the General Reserves account.
- 4) Treasurer's Report (see attachment)- Chuck Knox Chuck went over the financial position of the church, noting the year-end deficit of -46,386. He also noted that the church was blessed with some substantial giving during the month of December.
